ANNUAL MEETING NOTICE APRIL 2025

The Annual Membership Meeting of your water utility is Monday, June 9, 2025. The meeting, held in the Corporation Office and Treatment Plant located at 4735 W Carlos Folger Drive, Columbus, Indiana starts at 7:00 p.m. The Board invites all Members to attend. The meeting provides an opportunity to learn about the corporation's financial results, other 2024 accomplishments and for the future goals.

You will also have an opportunity to meet the Board of Directors and to participate in the election of one Director.

Nomination for the Board of Director's requires filing the <u>NOMINATION FOR BOARD</u> <u>OF DIRECTORS</u> form at the Corporation Office on or before 4:00 p.m. Friday, May 23, 2025.

The Board meets regularly on the second Monday of each month to review the preceding month's performance, to reevaluate and adjust in place plans and programs and consider future activities for your water utility.

In addition to attendance at the regular monthly Board meetings, Directors should be available to attend special meetings and to carryout specific assignments made by the President of the Board.

It is also desirable for the Board Member to bring to the Board skills and knowledge that will both expand and/or augment those of the previously elected Board Members.

SYSTEM IMPROVEMENTS UPDATE

In the summer of 2024, renovation began to the Ogilville multi-leg storage tank. This renovation included sand blasting, new welds, new safety climbing device, refurbish the catwalk, interior and exterior coatings, driveway, land restoration, and a new fence. The project expects to be completed by late spring 2025.

LEAD SERVICE LINE INVENTORY/REPLACEMENT

Environmental Protection Agency (EPA) has mandated a Lead Service Line Inventory and is ongoing for Public Water Suppliers watermains and service line material. A link on the website will take you directly to the survey. If you have not completed the survey, please do so. As of the date of this newsletter, no lead piping has been found anywhere in our system or in the service lines from the meter to the customer. Going forward SWBWC will continue to test and investigate per Federal Requirements. SWBWC has continued to meet or exceed all Federal and State requirements for water quality.

E-BILLING

If you would like to receive your water bill via email, please provide your email address to the office. There is also the option to sign-up for email on your customer portal. Water bills are mailed on the last business day of each month to allow office staff more time for account review.

Customers can pay their water bill online, send the company an email, forms, calendar of upcoming events, boil water advisories, list of Board of Directors. Customers need to set up an online portal for access to their account. Signing up for Auto-draft (ACH) is not available through the website currently. Please contact the office for any issues.

RATE INCREASE

Higher operating costs and the need to improve aging infrastructure, the City of Columbus has petitioned the Indiana Utility Regulatory Commission (IURC) for a rate increase to fund these costs. SWBWC is currently gathering data and testimony to file a request for a rate increase from the IURC. SWBWC increases will be due in part to those increases coming from the City of Columbus Utilities as well as ours to replace and/or upgrades to the system. A substantial portion of SWBWC piping dates to our inception in 1967 serving 800 members.

These are the base tariff and Phase 1, 2, and 3 "Water Tracker" rate increases prior to taxes.

Any damages caused to these properties will be charged to the customer and/or the contractor. Customers are encouraged to install an easily accessible shut-off valve for their personal use.

811 CALL BEFORE YOU DIG

Homeowners often make risky assumptions about whether they should get their utility lines marked, but every digging job requires a call even small projects like planting trees and shrubs. The depth of utility lines varies and there may be multiple utility lines in a shared area. Digging without calling can disrupt service to an entire neighborhood; harm you and those around you. Calling 811 before every digging job gets your underground utility lines marked for free and helps prevent undesired consequences. Call before you dig......It's the Law.
